SCHOOL AGREEMENT

This SCHOOL AGREEMENT ("Agreement"), dated February 28, 2023, is executed between Team

("Scholar"). The School and the Student are each referred to as a "Party" and, collectively, as
the "Parties".

Nature of Agreement

This academic agreement is for the current academic year. In exchange for training and academic assistance for one (1) academic year, the Scholar agrees to:

- Remain in good standing with the School; (No Attendance Reserve or Non Compliance)
- Maintain a grade point average of 2.0.;
- Log into all classes Monday through Friday and maintain acceptable attendance.
- Participate in enrichment activities as directed by the School; and,
- Comply with all rules and regulations prescribed by the Student Code of Conduct and other policies that may be issued by the School.

In consideration of the mutual promises and covenants in this Agreement, of which the receipt and sufficiency are hereby acknowledged, the Parties further agree to the terms as follows:

Terms and Conditions

TERMS

This Agreement shall remain in effect for one (1) academic year from the date of the Student enrollment in the School. This academic agreement may be extended beyond the one-year term at the sole discretion of the School. The Student understands that the School retains the right to terminate this Agreement at any time for reasonable cause.

TERMS CONT

Team Elite Sports Academy agrees to train and tutor the students between the hours of 8am-2:30pm. Parties agree to pick up students by 3pm and can set up a later time on a case by case basis. Parties agree that every day a student is not in attendance at Team Elite Sports Academy the student will log in and complete assignments and meetings. Any student that is placed on the Attendance Reserve or Non Compliant list parent will be liable to pay all fees the state pays Team Elite Sports Academy for student attendance. (\$300)

CONFIDENTIALITY

The Parties agree not to disclose any information relative to the academic agreement and this Agreement to any unauthorized party unless permitted by the School or mandated by law. Any and all information received by the Parties, whether this information directly or indirectly affects the image of the School, shall be kept confidential.

INDEMNIFICATION

The Student agrees to indemnify and hold harmless the School from and against any complaints, claims, and suits related to the Parties violations and acts of misconduct inside or outside campus grounds.

TERMINATION

The Student agrees to uphold its responsibilities and obligations set forth in this Agreement. The Student understands that the failure to abide by the terms herein may result in the discontinuation of the Students academic performance and the termination of this Agreement.

APPLICABLE LAW

This Agreement and the interpretation of its terms shall be governed by and construed under the laws of the State of California.
